NOTE FOR THE APPLICANT:

- 1 Children Education Allowance and Reimbursement of Tuition Fee which were hitherto payable separately has been merged and hereafter known as "Children Education Allowance Scheme". This Scheme is effective from 1st September 2008.
- 2 Under the Scheme of Children Education Allowance reimbursement can be availed by Government Servant upto a maximum of two children.
- Reimbursement as indicated above will be applicable for expenditure on the education of school going children only i.e., for children from classes nursery to twelfth, including classes eleventh and twelfth held by junior colleges or schools affiliated to Universities or Board of Education.
- 4 Henceforth, the reimbursement of Children Education Allowance shall have no nexus with the performance of the child in his class. In other words, even if a child fails in a particular class, the reimbursement of Children Education Allowance shall not be stopped.
- 5 The annual ceiling fixed for reimbursement of Children Education Allowance is Rs. 12000/-.
- 6 Under this scheme, reimbursement can be claimed once every quarter. The amount that can be claimed in quarter could be more than Rs. 3000/- and in another quarter less than Rs. 3000/-, subject to the annual ceiling of Rs. 12000/- per child being maintained.
- 7 Under this scheme, Education allowance for disabled children of an employee shall be paid double the normal rate.
- 8 In case both the spouses are Government servants, only one of them can avail reimbursement under Children Education Allowance.
- 9 Hostel subsidy will be reimbursed upto the maximum limit of Rs. 3000/- per month per child subject to a maximum of 2 children. However, both hostel subsidy and Children Education Allowance cannot be availed concurrently.
- Separate claim be submitted for each child alongwith respective original fee receipts' and cash memos'.

CHILDREN EDUCATION ALLOWANCE - TUITION FEE REIMBURSEMENT - CLARIFICATIONS

1 Order No. 12011/04/2008-Estt. (Allowance) dated 11.09.2008 of DoPT.

Reimbursement of Education Allowance for disabled children of Government employees shall be payable at double the normal rates prescribed. The annual ceiling fixed for reimbursement of Children Education Allowance for disabled children of Government Employees is Rs. 24000/-. The rest of the conditions will be the same as stipulated vide OM No. 12011/03/2008-Estt. (Allowance) dated 02.09.2008 on the subject.

2 Order No. 12011/16/2009-(Allowance) dated 13.11.2009 of DoPT.

It is clarified that Vidyalaya Vikas Nidhi charged by Kendriya Vidyalaya will also form part of para 1 (e) of the said OM (DPOT&M OM No. 12011/3/2008-Estt.(Allowance) dated 02.09.2008) and can be claimed for reimbursement under the scheme of Children Education Allowance subject to the annual ceiling of Rs.12000/- per child.

3 Order No. 12011/03/2008-Estt. (Allowances0 dated 23.11.2009 of DoPT.

It is clarified that classes nursery to twelfth will include classes I to XII + 2 classes prior to class I irrespective of the nomenclature.

It is further clarified that in respect of schools/institutions at nursery, primary and middle level not affiliated to any Board of education, the reimbursement under the Scheme may be allowed for the children studying in a recognized school/institution. Recognized school/institution in this regard means a Govt. school or any educational institution whether in receipt of Govt. aid or not, recognized by the Central or State Govt. or Union Territory Administration or by University or a recognized educational authority having jurisdiction over the area where the Institution is situated.

4 Clarification has been obtained from TIFR, Mumbai that -

If the original fee receipts are enclosed with claim, there is no need to obtain certificate from school/college.
